TOM REED GOLD MINES COMPANY



Tom Reed Gold Mine - Oatman, AZ

A July 22, 1916 article appeared in the Mohave County Miner written by Dr. J.M. Francis, a retiring Assistant Superintendent of the Tom Reed Gold Mines Company defending the company in reference to previous statements made by the Chamber of Commerce's secretary, W.K. Smith.

Mr. Smith accuses the company of "never contributing one penny to the Chamber of Commerce for the improvements of streets, the fire protection fund, or any expense of Oatman whatsoever." Dr. Francis admits to that direct charge but goes on to give us a lot of good historical information about what the Tom Reed Gold Mines Company did do for and on behalf of Oatman.

Before the gold boom, a lot of Oatman was built

on Tom Reed land. Two roads were built at a cost of \$3200, one going to the Oatman News office, and the other around the rear of the Walsh building (New Diggins). This basically describes the lower parking lot of Oatman today and roads leading off it.

Dr. Francis went on to say that the Tom Reed company furnished, free of charge to the town all the streetlights. It also provided once a week trash pickup for the two stores, the schoolhouse and private houses and provided the trash receptacles free of charge. The only condition required was that places be kept clean and garbage placed in the cans.

The company donated the first schoolhouse in Oatman and painted it twice. A later addition was paid for by the county. Half of the seats were donated by the then president of the company, Charley Grimes at a personal cost of \$200.

The company built the first road to Topock at a cost of \$30,000. At the time it was a private road but would later become part of the Old National Trails/Route 66 road.

Dr. Francis took further exception to figures given by Mr. Smith over the costs of public lavatories. Dr. Francis oversaw the building of a lavatory at Old Trails for the cost of \$425, whereas the one built by Lovin & Withers was built by the Chamber for \$170 and another at Mazona (located between Old Trails and Oatman) for \$20. Dr. Francis pointed out that the one built at Old Trails was a 20X26 structure, had a fence and a department for women! He went on to say that the Tom Reed company workers excavated the vaults for the lavatories at both the Oatman and Mazona locations and the Chamber only built the structures over the vaults.

The Tom Reed Gold Mines Company was incorporated in the Arizona Territory in 1906 and production began in 1908. It produced millions of dollars in gold and silver ore.

In response to this success the company invested a large sum of money to create a stamp mill on site, powered by water piped four miles from Cottonwood Canyon.

By the 1930's the mine was no longer producing ore and closed in March of 1932. The company continued until 1939 when it was formally shut down.

- Is the donor the legal owner of said materials?
- Do we have enough resources to maintain/store/display it.
- We cannot accept an artifact with stipulations on it such as it must be displayed in a particular way or time period.
- We do not accept loans.
